The Municipality of Reggio Emilia, based in Reggio Emilia, Piazza Prampolini 1, acting as per article 107 of the Legislative Decree no. 267/2000, represented by Giordano Gasparini, Director of the Cultural Institutions, hereinafter referred as «the Partner»

Article 1 : Object

The present agreement has for object to determine and organize the exchanges of partnership between the festival Circulation(s) and the Partner.

Article 2 : Duty of the festival Circulation(s)

Fetart offers the Partner to be a member of the jury for the selection of the artists exposed at the Festival Circulation(s) 2017, chosen from a call for application. For this purpose, the festival Circulation(s) has to send the images of the selected artists by webmail 48 hours before the jury so that the votes of the Partner can be counted during deliberations. The Partner has the possibility of participating in the jury in a physical way but in his expenses.

On the other hand, the Partner offers Fetart the possibility to be a member of the jury for the selection of the 7 artists for the exhibition Giovane Fotografia Italiana, to be exposed at the Festival Fotografia Europea 2017 in Reggio Emilia, chosen from a public call for application.
