Dear POLIS member,

Following our Annual General Assembly in Brussels last December, where we together defined the priorities for 2023, we look forward to further enhancing our membership services and network activities and continuing our cooperation with you.

We were delighted to meet so many of you in person in Brussels. The POLIS conference welcomed over 800 participants, which proves how energising and important face-to-face meetings still are. The past period has also shown us more than ever how important peer-to-peer exchange is, and in 2023, we will continue to offer you the high-quality and tailored services you are used to, both in digital and physical format.

As you know, during the Extraordinary and Annual General Assembly, POLIS adopted a few amendments regarding its Statutes, elected the members of the Management Committee and the President, adopted the 2023 budget and strategy, as well as the new membership fees. The membership fees, which had not been amended since 2009, are increased with 5% in 2023 and another 5% in 2024, based on the 2022 fee. There will not be an "early bird" discount anymore. In Belgium, the cumulative inflation between 2009 and today represents 37,03 %, while the average annual inflation rate between these periods has been 2,45 %. We thank you that you considered the proposal of the Management Committee and Secretariat for an increase of the membership fee to be fair and reasonable.
