on one hand,

and

The Municipality of Reggio Emilia, based in Reggio Emilia, Piazza Prampolini 1, acting as per article 107 of the Legislative Decree no. 267/2000, represented by Valentina Galloni, Director of the Cultural Services, hereinafter referred to as «the Municipality»
on the other hand,

Article 1: Object

The present agreement has for object to determine and organize the exchanges of partnership between Fotodok and the Municipality.

Article 2: Duty of the Municipality

The Municipality offers a representative of Fotodok the possibility to be a member of the jury for the selection of the 7 artists, chosen from a public call for application, for the exhibition Giovane Fotografia Italiana, 11th edition, promoted by the Municipality of Reggio Emilia in collaboration with GAI - Associazione per il circuito dei giovani artisti italiani and Fotografia Europea festival 2024.

The Municipality commits to host a representative of Fotodok in Reggio Emilia during the opening days of the festival (April 26th - 28th 2024) by covering travel, board and lodging expenses.

The Municipality commits to host selected works from the Fotodok programme, agreed by both parties, as an images' projection, temporary exhibition, event, or talk in the edition 2024 of Giovane Fotografia Italiana - Fotografia Europea to be held in Reggio Emilia from April 26th to June 9th 2024. The Municipality commits to put an information board on the exhibition place about the Fotodok programme.

The Fotodok logo will be on the following communication media supports of the festival:

- the press kit
- the website gfi.comune.re.it

The Municipality commits to provide information via its social media on selected activities and events in the Fotodok programme for 2024, agreed by both parties, such as calls for application and openings.

Article 3: Duty of Fotodok

FOTODOK commits to provide visibility to Giovane Fotografia Italiana for the upcoming year 2024 in a form to be discussed and within the limits and resources available. The abovementioned can take shape in a projection within an exhibition, a talk/presentation, or a small event. Fotodok commits to

hosting a representative of Giovane Fotografia Italiana by covering travel, board, and lodging expenses. Fotodok commits to positioning an introduction text in the exhibition venue with information about the project and the artists.

The logos of the Giovane Fotografia Italiana promoters will be present as festival partner on the following communication media supports:
